AN ORDINANCE DETERMINING THE COMPENSATION RATES TO BE PAID TO THE APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF REMINDERVILLE, EFFECTIVE DECEMBER 24, 2023, AND DECLARING AN EMERGENCY.

WHEREAS, Council has determined there is good cause to set the compensation rates for the appointed officers and employees of the City of Reminderville, effective December 24, 2023, therefore,

SECTION 2.
