A RESOLUTION TO HIRE BRANDON ARNOLD, XAVIER BOARD, LUKE KREMSER, NOELLE LUCARELLI, MYKAYLA McCLENDON, HANNAH PICKENS, FAYE SCHULLER, AND CAMERON SUGGS AS RECREATION AIDES FOR THE REMINDERVILLE ATHLETIC CLUB AND TO BE PAID TWELVE DOLLARS AND 00/100 (\$12.00) PER HOUR, AND DECLARING AN EMERGENCY.

WHEREAS, the Director of the Reminderville Athletic Club has recommended hiring Recreation Aides for the Reminderville Athletic Club, and

WHEREAS, Council finds good cause to accept the recommendation of the Director of the Reminderville Athletic Club and; therefore,

NOW, BE IT RESOLVED by the Council of the City of Reminderville, County of Summit, State of Ohio:

SECTION 1. That Brandon Arnold is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 2. That Xaviar Board is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 3. That Luke Kremser is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 4. That Noelle Lucarelli is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 5. That McKayla McClendon is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 6. That Hannah Pickens is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 7. That Faye Schuller is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 8. That Cameron Suggs is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective March 27, 2024, to be paid at the rate of \$12.00 per hour.

SECTION 9: The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
