

**RESOLUTION NO. 34-2024**

**OFFERED BY: Mayor Alonso**

**A RESOLUTION TO HIRE CARL BARTLETT, DAVID HORVATH, AND MICHAEL MIKOVIC AS PART-TIME FIREFIGHTERS WITH THE CITY OF REMINDERVILLE FIRE DEPARTMENT AND TO BE PAID AT THE RATE OF TWENTY-FIVE DOLLARS AND 03/100 (\$25.03) PER HOUR, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Fire Chief has recommended the hiring of part-time firefighters for the Reminderville Fire Department based on the current community needs, and

**WHEREAS**, the Fire Chief has determined that Carl Bartlett, David Horvath, and Michael Mikovic are qualified as certified firefighters in the State of Ohio and are in the process of completing the City of Reminderville's hiring protocols, and

**WHEREAS**, Council has determined that there is good cause to accept the recommendation of the Fire Chief, therefore:

**NOW, BE IT RESOLVED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That if Carl Bartlett successfully completes the City of Reminderville's hiring protocols, he is hereby hired as a part-time firefighter in the Reminderville Fire Department, to be paid \$25.03 per hour.

**SECTION 2.** That if David Horvath successfully completes the City of Reminderville's hiring protocols, he is hereby hired as a part-time firefighter in the Reminderville Fire Department, to be paid \$25.03 per hour.

**SECTION 3.** That if Michael Mikovic successfully completes the City of Reminderville's hiring protocols, he is hereby hired as a part-time firefighter in the Reminderville Fire Department, to be paid \$25.03 per hour.

**SECTION 4.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 5.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
