Approval of Minutes

Jordan Menvielle 3374 Greens Pointe

Mr. Menvielle stated he has concerns about the flock safety cameras that were installed in Reminderville. He understands the positive safety aspect of the cameras in assisting law enforcement in solving crimes and tracking a vehicle possibly containing a missing person but he is concerned about the cameras constantly tracking the movement of everyone every day whether or not they have committed a crime. He feels it is a terrifying price to pay for a little security. He continued that the software is using artificial intelligence to

create a database about daily routines. The software is able to track his commute through cameras in different cities to and from work in Akron every day without his knowledge or consent. The cameras are not owned by the Reminderville Police Department but stored in a cloud system run by a private corporation he knows nothing about and is expected to trust them with the data and trust there are proper steps being taken to protect from data breaches, cyberattacks, or hackers. He feels the data collected can lead to people figuring out when someone is not home. He cited an article in Forbes magazine that reported flock safety repeatedly broke the law. Several states have banned flock cameras and he feels the installation of cameras in the City is a gross violation of his privacy and poses more of a threat to his safety than to crimes being solved.

Chief Berquist responded he understands Mr. Menvielle's concerns and he understands the cameras come with positive and negative elements but he feels the positive outweighs the negative. All of the surrounding cities have the cameras and they are used to assist each other's departments. The police officers run license plates through a computer in their cars to check for warrants as part of their daily duties and there is a trust that the information will be protected just like any information from the cameras. The cameras record cars coming in, not going out.

Mr. Menvielle said he still disagrees with the cameras but appreciated the statement. He is more concerned with the company that is monitoring the database.
