

**RESOLUTION NO. 46-2024**

**OFFERED BY: Mayor Alonso**

**A RESOLUTION TO TRANSITION THE POSITIONS AND PAY RATES OF STEVE PAGANO, MICHAEL BERQUIST, JAMIE SIEGFRIED, AND MARCO BERQUIST WITH THE CITY OF REMINDERVILLE POLICE DEPARTMENT.**

**WHEREAS**, the Mayor has recommended the transition of position and pay of several administrative officers within the Reminderville Police Department based on current community needs, and

**WHEREAS**, the Mayor has recommended Steve Pagano, Michael Berquist, Jamie Siegfried, and Marco Berquist for position and pay transitions, and

**WHEREAS**, Council has determined that there is good cause to accept the recommendation of the Mayor, therefore:

**NOW, BE IT RESOLVED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That Steve Pagano is hereby transitioned to the position of Detective Sergeant and to be paid at a rate of thirty-seven dollars and 17/100 (\$37.17) per hour effective September 29, 2024.

**SECTION 2.** That Michael Berquist is hereby transitioned to the position of Lieutenant and to be paid at a rate of forty dollars and 89/100 (\$40.89) per hour effective September 29, 2024.

**SECTION 3.** That Jamie Siegfried is hereby transitioned to the position of Captain and to be paid at a rate of forty-four dollars and 98/100 (\$44.98) per hour effective September 29, 2024.

**SECTION 4.** That Marco Berquist as the Police Chief is hereby transitioned to a pay rate that is ten percent (10%) above the current pay rate of Captain; he is to be paid at a rate of one hundred two thousand nine hundred eighteen dollars and 40/100 (\$102,918.40) per year effective September 29, 2024.

**SECTION 5.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 6.** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
