**A RESOLUTION TO HIRE NICHOLAS MARRALI, JULIA MILLER, JACKSON FARLEMAN, JACE JONES, SEAN MCKINLEY, JACKSON SIMMERSON, AND RILEY VILECAN AS RECREATION AIDES FOR THE REMINDERVILLE ATHLETIC CLUB AND TO BE PAID TWELVE DOLLARS AND 00/100 (\$12.00) PER HOUR, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Director of the Reminderville Athletic Club has recommended hiring Recreation Aides for the Reminderville Athletic Club, and

**WHEREAS**, Council finds good cause to accept the recommendation of the Director of the Reminderville Athletic Club and; therefore,

**NOW, BE IT RESOLVED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That Nicholas Marrali is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 2.** That Julia Miller is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 3.** That Jackson Farleman is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 4.** That Jace Jones is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 5.** That Sean McKinley is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 6.** That Jackson Simmerson is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 7.** That Riley Vilecan is hereby hired as a Recreation Aide for the Reminderville Athletic Club, effective August 14, 2024, to be paid at the rate of \$12.00 per hour.

**SECTION 8:** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 9.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
