

**RESOLUTION NO. 75-2024**

**A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (“MOU”) WITH THE TINKERS CREEK WATERSHED PARTNERS, INC., AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Tinkers Creek Watershed Partners, Inc. (TCWP) formed from an alliance between the Tinkers Creek Land Conservancy and the Cuyahoga Board of Health in 2005, and

**WHEREAS**, the Tinkers Creek Watershed Partners, Inc., is an independent non-profit organization that partners with communities to help meet their needs for managing stormwater and natural resources, provide assistance to local communities in the areas of community engagement, grant writing, expert consultation and issue advocacy to conserve and restore water quality and habitats in the Tinkers Creek Watershed, and

**WHEREAS**, the City of Reminderville is a member in good standing of the TCWP, and,

**WHEREAS**, Council finds good cause to authorize the mayor to execute the MOU with the Tinkers Creek Watershed Partners, Inc., and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That the mayor is hereby authorized and directed to execute the Memorandum of Understanding with the Tinkers Creek Watershed Partners, Inc., effective January 1, 2025 through December 31, 2025, and take all steps necessary to consummate such MOU.

**SECTION 2.** That a copy of such MOU shall be attached hereto and expressly incorporated herein.

**SECTION 3.** The Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville to wit: to perfect filing within the time period required by law. If this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
